You must be registered with eVA (<u>www.eva.state.va.us</u>) and the E-Verify Program (<u>https://www.uscis.gov/e-verify</u>) in order to be awarded the project.

Mr. Robert Roth, P.E., the VDOT Project Manager, will be responsible for the administration of this contract. The VDOT Project Manager may be contacted by calling 757-956-3220. The Baseline Schedule, in accordance with Part 3, Lump Sum Design-Build Agreement, Article 11.1.2, must be prepared and sent to the VDOT Project Manager for review and approval within ninety (90) days of the Date of Commencement. The VDOT Project Manager shall also be notified of the names of the plants and producers from which the materials are to be supplied on a Department furnished source of material form C-25, also available on VDOT's website.

After formal action by the Commonwealth, you will be advised accordingly.
