Virginia Regulatory Town Hall Information

From time to time the Viriginia Department of Transportation (VDOT) and Commonwealth Transportation Board (CTB) undertake periodic reviews of and changes to their regulations. These actions are posted on the Virginia Regulatory Town Hall. Stakeholders such as citizens and locality staff may register on the Town Hall to receive notices when an entity such as the CTB or VDOT is proposing to take an action on a regulation. Registration with Town Hall provide the registrant sufficient notice to submit comments in response to the proposed action.

Localities that may have an interest in CTB or VDOT regulations are encouraged to subscribe. Instructions for subscribing and registering can be found at the following link: **Register as a public user**. Once registered, you will receive an email with a link to activate your account and modify or specify email preferences.

Compliance Program Updates

On September 29, 2023, LAD emailed the FY 2023 Federal Sub-Recipient Reporting letter to all localities for which VDOT disbursed more than \$100,000 in federal funds in FY 2023. For these sub-recipients, certain federal requirements may apply depending on the amount of federal funds received from all sources, not just VDOT. The letter included a reminder for sub-recipients to submit the Annual Comprehensive Financial Report's (ACFR's), annual financial audit and Single Audit Reports (if separate from ACFR) no later than March 31, 2024.

The letter, FY 2023 Response Form and FY 2023 Sub-recipient Expenditure Spreadsheet are all included on our <u>Locally Administered Projects</u> website.

Public Right-of-Way Accessibility Guidance (PROWAG) Final Rule Notice for Districts

The U.S. Architectural and Transportation Barriers Compliance Board (Access Board) recently issued its final rule for accessibility guidelines for pedestrian facilities in public rights-of-way (PROWAG or guidelines)effective September &, 2023. These guidelines are issued under Title II of the Americans with Disabilities Act of 1990 (ADA) and the Architectural Barriers Act of 1968 (ABA). Title II of the ADA applies to State and local government facilities, among others. The ABA applies to facilities constructed or altered by or on behalf of the Federal Government, facilities leased by Federal agencies, and some facilities built with Federal funds, including those funded through VDOT.



The purpose of the guidelines is to ensure that pedestrian facilities located in the public right-of-way are readily accessible to and usable by pedestrians with disabilities. Despite on-going efforts to improve access, pedestrians with disabilities throughout the United States continue to face major challenges in public rights-of-way because many sidewalks, crosswalks, and other pedestrian facilities are inaccessible. Equal access to pedestrian facilities is of particular importance because pedestrian travel is the principal means of independent transportation for many persons with disabilities.

Key accessible features of pedestrian facilities specified in these guidelines include:

- Pedestrian Access Routes: Sidewalks, shared use paths and other pedestrian circulation paths must contain a "pedestrian access route," which is required to be accessible to and traversable by individuals with disabilities. The portions of these sidewalks and paths that comprise the pedestrian access route must be wide enough to minimize the possibility of a pedestrian using a mobility device falling into a roadway when passed by another pedestrian. Pedestrian access routes have specified cross slopes and running slopes so that they are traversable by pedestrians using manual wheelchairs or other mobility aids without exhaustive effort. Surfaces of paths in the pedestrian access route must be firm, stable, and slip resistant, without large openings or abrupt changes in level. Objects may not hazardously protrude onto sidewalks, shared use paths, or other pedestrian circulation paths.
- Alternate Pedestrian Access Routes: When an entity closes a pedestrian access
 route for construction, it must provide a temporary alternate pedestrian access
 route with basic accessible features. Alternate pedestrian access routes ensure that
 construction in the public right-of-way does not prevent pedestrians with disabilities
 from reaching their destinations.
- Accessible Pedestrian Signals: All new and altered pedestrian signal heads
 installed at crosswalks must include "accessible pedestrian signals" (APS), which
 have audible and vibrotactile features indicating the walk interval so that a
 pedestrian who is blind or has low vision will know when to cross the street.
 Pedestrian push buttons must be located within a reach range such that a person
 seated in a wheelchair can reach them. The walk speed used to calculate the
 crossing time allows pedestrians with disabilities sufficient time to cross.



- **Crosswalks:** Curb ramps and detectable warning surfaces are required where a pedestrian circulation path meets a vehicular way. Crosswalks at multilane roundabouts and channelized turn lanes must have additional treatments that alert motorists to the presence of pedestrians or slow or stop traffic at those crosswalks.
- **Transit Stops:** Boarding and alighting areas at sidewalk or street level, as well as elevated boarding platforms, must be sized and situated such that a person with a disability can board and alight buses and rail cars. Pedestrian access routes must connect boarding and alighting areas and boarding platforms to other pedestrian facilities. Transit shelters must have clear space for use by a person in a wheelchair.
- **On-Street Parking:** On-street non-residential parking must have designated accessible parking spaces sized so that a person with a disability may exit a parked vehicle and maneuver to the sidewalk without entering a vehicular way. Standard size designated accessible on-street parking spaces must be situated near an existing crosswalk with curb ramps.

The following excerpt was taken from guidance provided by VDOT State L&D Engineer Emmett Heltzel, P.E. and State Traffic Operations Engineer Mark Cole, P.E. on 8/16/2023:

"As many of you may already be aware, the Access Board recently issued its <u>Final Rule</u> regarding Accessibility Guidelines for Pedestrian Facilities in the Public Right-of-Way. The rule provides updated guidelines to ensure the accessibility and usability of pedestrian facilitates within the public right-of-way, including for pedestrians with disabilities.

At this time, these latest guidelines have not been officially adopted by VDOT and, until you receive further notice, VDOT should continue to execute our work per our existing policies and practices. As the U.S. Departments of Justice (DOJ) and Transportation (DOT) work towards consideration of further federal adoption, Central Office Location & Design (L&D) and Traffic Operations Divisions (TOD) alongside the Civil Right Division and other partners will be working with FHWA to determine the specific details of formal acceptance of the new guidance into VDOT policy and practice. Formal direction will be provided when these guidelines are to be incorporated into VDOT's work."

VDOT Districts will continue to advise localities concerning implementation of PROWAG as the policy is developed. Any questions concerning PROWAG should be directed to your Local Project Coordinator.

3- Year Renewal Qualification Program Update

The re-certification program is currently being transferred from Talent LMS to the Virginia Department of Transportation University (VDOTU). During this transition period, re-certifications are on hold and certifications set to expire between October 15, 2023, and December 30, 2023, are being extended for 60days. (Ex. Qualification certificates set to expire on October 15, 2023, now have an expiration date of December 14, 2023.) All affected individuals have been contacted via email.

When the re-certification QP course is launched in VDOTU, affected individuals will be notified with additional information and instructions on how to access the course content. Please note that this course is different from the QP course in that it is a refresher that covers the Project Management modules. For the re-certification QP course, you will need to complete the eight (8) QP - Project Management modules (versus the 12 modules in the full QP course). Each module includes a lecture, video(s), short quiz and resource links. For quizzes, the minimum passing score is 80%; quizzes may be retaken as many times as necessary to achieve a passing score. There is no final exam. Your re-certification will be valid for three years from the date of course completion.

The State Trails Office is planning three virtual engagement forums, offering the public opportunities to provide feedback or ask questions about the Statewide Trails Plan.

The Statewide Trails Plan aims to lay the groundwork for a network of multiuse trails by inventorying existing and proposed trails, identifying key gaps in the network of trails, outlining the next steps and best practices in multi-use trail development, and providing opportunities for community engagement.

Public participation in these forums is valuable in the planning process for laying the groundwork for a network of accessible and connected multi-use trails across Virginia. The presentations will be the same across the three forums, so the public can choose the date and time that works best for them.

FY25 SGR Local Paving Application Cycle


The SGR Local Paving application intake period opened in the Smart Portal on October 10, 2023, and will close on December 8, 2023, at 5:00 PM. Funding for selected projects is anticipated to be available on July 1, 2024. Applications must follow the federal process. Localities will have an opportunity to request an exception to the federal process in the Spring of 2024, after the project selection is complete. The application funding limit remains at \$1.5 million per locality, per fiscal year. Selected projects must be advertised within 12 months of receipt of funding. Pursuant to federal laws, certain maintenance activities trigger compliance with the Americans with Disabilities Act (ADA). Projects funded through this process must meet the minimum threshold for ADA compliance and the project estimates should include the amount required to comply with these requirements. FY25 SGR Local Bridge Application Cycle



(Target: 70% of Projects Complete Development Phase On-Time)




(Target: 74% of Projects Complete Development Phase On-Budget)



Active VDOT - LAP Percent of CN Project 3,862 Total Projects






