### Estimated Cost - \$18.6 million

**Purpose** – To widen the roadway from two lanes to four lanes with median and shared use path to add capacity to accommodate anticipated growth.

From – Route 60 (Richmond Road)

To – Point O' Woods Road

Total length – 0.73 miles

Improvements – Widen Route 607 (Croaker Road) from two lanes to four lanes with median, provide a shared use path from Route 60 (Richmond Road) to the James City County Library, construct a new bridge over CSX Railroad, and improve the intersection at Route 607 (Croaker Road) and Route 60 (Richmond Road).

# **PROJECT DESCRIPTION**

The project includes construction of two additional lanes in the southbound direction with a 12-footwide inside through lane and a 14-foot-wide outside through lane to also accommodate bicycles. The existing two lanes will be converted to two northbound lanes and will be slightly widened to the east with a 12-foot-wide inside through lane and a 14-foot-wide outside through lane to also accommodate bicycles.

The project also includes construction of a shared use path from Route 60 (Richmond Road) to the James City County Library.

In addition, the project will improve the intersection at Route 607 (Croaker Road) and Route 60 (Richmond Road) by providing a left turn lane, a shared left turn through lane, and a right turn lane in the southbound direction. Pedestrian accommodations at this intersection will also be coordinated with adjacent construction projects.

The proposed southbound bridge over CSX Railroad, which will be built to accommodate two lanes and a shared use path, is separated from the traffic lanes by a concrete parapet and steel railing.

Access to all properties and traffic in both directions will be maintained during construction.

The design of this project is in compliance with the Stormwater Management Act, stormwater regulations, and the annual stormwater management standards and specifications approved by the Virginia Department of Environmental Quality.

# **Estimated Project Cost**

### Total Cost: \$18.6 million

Preliminary Engineering - \$1,452,000 **Right of Way - \$2,509,000** Construction - \$14,650,000

The project is in the early design stages and cost is subject to change. The project will be financed using state and federal funds.

## **Environmental Review**

A Categorical Exclusion (CE) has been prepared and approved for this project. The document is available for public review here tonight. Through on-site inspections, and coordination with federal, state, and local agencies, the Virginia Department of Transportation (VDOT) (with concurrence from the Federal Highway Administration) has determined that the proposed work will not have any significant environmental impacts.

All applicable permits required for impacts to existing wetlands will be acquired prior to project construction. All impacts will be mitigated as required by the permitting.

On behalf of the Federal Highway Administration and in accordance with Section 106 of the National Historic Preservation Act, VDOT has taken into account the effects of this undertaking on historic properties and has consulted with the Virginia State Historic Preservation Officer (VA SHPO), the director of the Virginia Department of Historic Resources. In order to identify historic properties that are within the project's area of potential effect, VDOT conducted architectural and archaeological surveys of the project area. The Virginia Department of Historic Resources concurs with VDOT that the project as proposed will have no adverse effect on historic properties.
